Dear Shareholder,

Subject: Common and simplified norms for processing investor's service request by RTA and Norms for furnishing PAN, KYC details and Nomination

We wish to bring to your notice that Securities & Exchange Board of India (SEBI) vide its circular SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated November 03, 2021 read with Circular SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated December 14, 2021 has prescribed common and simplified norms for processing any investor's service request by Registrar & Share Transfer Agent (RTA) and mandatory furnishing of PAN, KYC details and Nomination by holders of physical securities.

SEBI, vide the said circulars, also specified the formats for physical shareholders for raising the requests with regard to registration or changes / updation of PAN, KYC, nomination and also for banker's attestation of the signature of the shareholder in the event of major mismatch in the signature of the shareholder.

In this connection, please find enclosed the following forms notified by SEBI:

- a. Form ISR-1 (Request for registering PAN, KYC details or changes/updation thereof)
- b. Form ISR-2 (Confirmation of Signature of securities holder by the Banker)
- c. Form SH-13 (Nomination form)
- d. Form ISR-3 (Declaration for opt-out of Nomination)
- e. Form SH-14 (Change in Nomination)

Please note that -

- It has been made mandatory for shareholders holding physical shares to furnish PAN, KYC details viz. Contact Details, bank details, signature etc. and Nomination details to the Company or its RTA. These would be validated by the RTA through the mobile number and email address provided by the shareholder.
- Service Requests relating to the aforesaid matters shall be made only in Form ISR-1.
- Change in specimen signature shall be in Form ISR-2 duly attested as specified in the Form.
- All eligible physical holders shall furnish Nomination in Form SH-13 or Declaration to Opt-out in Form ISR-3.

- In case of changes or cancellation of Nomination made earlier, it shall be in Form SH-14.
- Where nomination is cancelled but no fresh nomination is made, please provide Declaration to Opt-out in Form ISR-3.
- Folios, in which PAN is not linked to Aadhaar as on 31.03.2022 or any other date as may be specified by the Central Board of Direct Taxes, will also be frozen by the Company's RTA.
- Folios in which PAN / KYC/ Nomination details are not available / updated will be frozen by the Company's RTA w.e.f. 01.04.2023.
- Frozen folios would be reverted to normal status by RTA only upon the prescribed information have been furnished or the entire shares under the folio dematerialized.
- If such folios continue to remain frozen as on December 31, 2025, the frozen folios would be referred by RTA / Company to the concerned authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002.
- w.e.f. 01.01.2022, any service request will be entertained by the Company's RTA only upon registration / updation of PAN, KYC and Nomination details.

At this juncture, we once again request the shareholders holding shares in physical form for getting their physical shares converted to demat at the earliest.

- 1. In Person Verification (IPV): by producing the originals to the authorized person of the RTA, who will retain copy(ies) of the document(s)
- 2. In hard copy: by furnishing self-attested photocopy(ies) of the relevant document, with date
- 3. Through e-mail address already registered with the RTA, with e-sign of scanned copies of documents
- 4. Service portal of the RTA with e-sign with scanned copies of documents, if the RTA is providing such facility

Note:

- It is mandatory for holders of physical securities in listed company to furnish PAN, full KYC details (address proof, bank details, e-mail address, mobile number) and Nomination (for all the eligible folios).
- Upon receipt or up-dation of bank details, the RTA automatically, pay electronically, all the moneys of / payments to the holder that were previous unclaimed / unsuccessful.
- RTA shall update the folio with PAN, KYC details and Nominee, within seven working days of its receipt. However, cancellation of nomination, shall take effect from the date on which this intimation is received by the company / RTA.
- RTA shall not insist on Affidavits or Attestation / Notarization or indemnity for registering / up-dating / changing PAN, KYC details and Nomination.

Objection Memo that can be raised by the RTA

(only if the relevant document / details is / are not available in the folio or if there is a mismatch / discrepancy in the same or change thereof)

Note

RTAs shall raise all objections, if any / at all, in one instance only; the RTA shall not raise further objections on the same issue again and again, after the holder / claimant furnishes all the prescribed documents and details, unless there is any deficiency / discrepancy in the same.
