1. I,Susanta Kumar Hota, proprietor of M/s S. K. - 4. The Company had availed the E-voting facility offered by Central Depository Services (India) Limited ("CDSL") for providing E-voting facility to the Members of the Company prior to AGM as well as e-voting during the AGM.
- The shareholders of the Company holding shares on the "cut-off date" of 21st September, 2021 were entitled to vote on the resolutions as set out in the notice of the 38<sup>th</sup> Annual General Meeting.
- The remote e-voting was opened on 25<sup>th</sup> September, 2021 at 10.00 A.M. (IST) and ended on 27<sup>th</sup> September, 2021 at 5.00 P.M (IST) and thereafter, CDSL remote e-voting platform was disabled.
- 7. The Company also provided e-voting facility to the shareholders present at the AGM held through VC/OAVM. Shareholders, who were present at the AGM and had not cast votes by remote e-voting facility, were allowed to cast their votes through e-voting during the AGM.
- 8. After the closure of e-voting at AGM, the votes cast under remote e-voting before the AGM and e-voting done at the time of AGM were unblocked and calculated in the presence of two witnesses, viz., Mr. Sanjay Adhikari and MrsCharubala, who are not in the employment of the Company and who have signed below as confirmation to unblocking of the votes.
